### RCC FRAMED STRUCTURE WITH GROUND AND FIRST FLOOR.

(The Foundation provided is designed to withstand the super imposed load from Ground, First and Second Floor. Construction of Ground and First Floor has been completed in all respect)

- (a) **Foundation** : Isolated RCC Columns, Footings, Column base in 1:2:4 Mix. concrete over plain cement concrete bed 1:5:10 Mix. and sand cushion. Four numbers of Isolated columns for main Portico in ground floor at main entrance 4 isolated column are provided at Ground floor main entrance with High roof. 2 Nos of small portico on sides each supported with 2 isolated Column with Normal roof height. Above this Small portico 2 rooms are provided. One room on Each floor and they are utilized for Transport office & Staff room. RR masonry in CM 1:6 mix for provision of Compound wall.

**(b) Basement** : RCC Columns and Tie beams in 1:2:4 Mix. concrete. RR Masonry in CM

**(c) Superstructure** : Brick work in 1:6 Mix. interlinked with RCC columns, Tie beams, And Lintel Level beams and Sunshades with RCC 1:2:4 concrete and plastered in Cement Mortar. For access to all floors, three numbers of staircases are provided with RCC slab and steps with brick work. Handrails with M. S. Tubular Sections. Corridor with isolated square columns with RCC sunshade and brick work parapet wall are constructed in all floor are safety with brick wall interlinked with Isolated columns. In first floor part of the brick wall with steel design grills. Joineries with steel door with frame and steel windows with fixed grill, Water supply with the bore well and supplied to RCC over head tank. Provisions has been made for solar water heating system, and sewage Treatment Plant. Compound has been constructed in Hollow block and pointing with 1:6 mix. In Second floor, Stair head room has been provided.

**(d) Floor** : Floor area of rooms, corridor, portico and steps with Vitrified Tiles Over plain cement concrete 1:5:10 Mix.

**(e) Roof** : Ground and First Floor Roof with RCC slab and beam in 1:2:4 Mix. concrete Including portico areas.






